TO KEEP IN MIND

Low stocks of hepatitis B vaccines and obligatory vaccination

Vaccination should preferentially be available for healthcare personnel and those who have never previously been vaccinated. The decree of 2 March 2017 suspends appendices I and II of the decree of 2 August 2013.

Decree of 2 March 2017 suspending appendices I and II of the decree of 2 August 2013

In response to the low stocks of hepatitis B vaccines, this decree sets out the conditions for inoculation of the persons mentioned in article L. 311-4 of the French Public Health Code.

Decree No. 2017-812 of 5 May 2017, revising and completing the occupational disease tables, appended to book IV of the French Social Insurance Code

For the general social insurance regime, this decree modifies parts D and E of table No. 57, table No. 79 and creates tables Nos. 52b and 99.
