Bladder cancer and occupational exposure to cutting fluid: epidemiological study among French metal workers

This case-control study suggests that occupational exposure to cutting fluid is associated with an increased risk of bladder cancer, with an onset between 5 and 25 years after the exposure.

Workers exposed to biological agents. Results of the SUMER 2009-2010 survey

Slightly over one in five workers are exposed to biological agents. This exposure is mainly classed as «potential». «Deliberate» exposure is linked to research or biotechnology.

The aim is to provide indicators to prevent occupational detachment in agreements signed between occupational health services and occupational health and pension insurance funds (CARSAT).
